AN Act TO AMEND THE GREATER COLOMBO ECONOMIC
COMMISSION LAW, No. 4 OF 1978.

BE it enacted by the Parliament of the Democratic Socialist
Republic of Sri Lanka as follows:—

1. This Act may be cited as the Greater Colombo
Economic Commission (Amendment) Act, No. 21 of 1983. Start title.

2. Section 14 of the Greater Colombo Economic Com-
mission Law, No. 4 of 1978, (hereinafter referred to as the
“principal enactment”) is hereby amended in subsection
(1) of that section by the substitution for the words “such
departments”, of the words “such departments or
agencies”. Amendment
of section 14
of Law No. 4
of 1978.

3. Section 20 of the principal enactment, as amended by
Act No. 43 of 1980, is hereby further amended in subsection
(1) of that section, as follows:— Amendment
of section 20
of the
principal
enactment.

(a) by the substitution for the expression “Schedule C”,
of the expression “Schedule C or Schedule D”;
and

(b) by the substitution for the words “reference to the
Commission.”, of the following:—

“reference to the Commission:

Provided, however, that no by-law, regulation,
order or notification shall be made or issued by the
Commission under the National Environmental
Act, No. 47 of 1980, or any power or function
exercised or discharged by the Commission under
that Act except in consultation with, and the con-
currence of, the Central Environmental Authority
established by that Act.”.

4. Section 28 of the principal enactment is hereby
amended in subsection (2) of that section, by the substitu-
tion, for the words “five years”, of the words “three
years”. Amendment
of section 28
of the
principal
enactment.

5. The principal enactment is hereby amended by the
addition, immediately after Schedule C, of the following
new Schedule which shall have effect as Schedule D to the
principal enactment:— Addition
of new
Schedule D
to the
principal
enactment.

The Tourist Development Act, No. 14 of 1968.

The Sri Lanka Land Reclamation and Development Corporation
Act, No. 15 of 1968.

The National Environmental Act, No. 47 of 1980.

The Companies Act, No. 17 of 1982.”.
