1. The Chairman, Department Procurement Committee, on behalf of the Board of Investment of Sri Lanka invites sealed bids from eligible and qualified bidders for construction of perimeter electric fence at Mirijjawila Export Processing Zone, Hambantota

2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements.

**Required Construction Industry Development Authority (CIDA) Registration**

Specialty : Building Construction

Grade : C8 and above

4. Qualification requirements to qualify for contract award include:  
**Successful Bidder should have completed at least one contract of similar nature over the period of last 5 years.**

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the Director (Zone), Board of Investment of Sri Lanka, Koggala Export Processing Zone, Koggala, Habaraduwa from 18.12.2018 until 04.01.2019 between 0900 hrs and 1500 hrs. upon payment of a non-refundable fee of Rs.3000.00 +VAT. The method of payment will be by cash.

7. Sealed Bids shall be delivered in duplicate to reach the Chairman, Regional Procurement Committee, C/o Director (Zone), Board of Investment of Sri Lanka, Koggala Export Processing Zone, Koggala, Habaraduwa on or before 1400 hours on 07.01.2019. Late bids will be rejected. Bids will be opened soon after closing time in the presence of the bidders' representatives who choose to attend.

8. Bids shall be valid up to 08.04.2019.

9. All bids shall be accompanied by a Bid-Security of Rs.50, 000.00. Bid Security shall be valid up to 04.05.2019.
